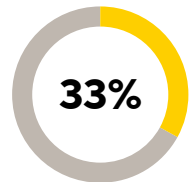

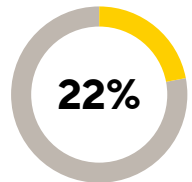

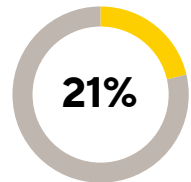
% BREAKDOWN OF

GEOGRAPHICAL LOCATION



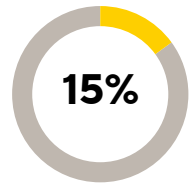

Countries and continents have been grouped following the official UN classification, except for Cyprus, which has been listed under Europe.





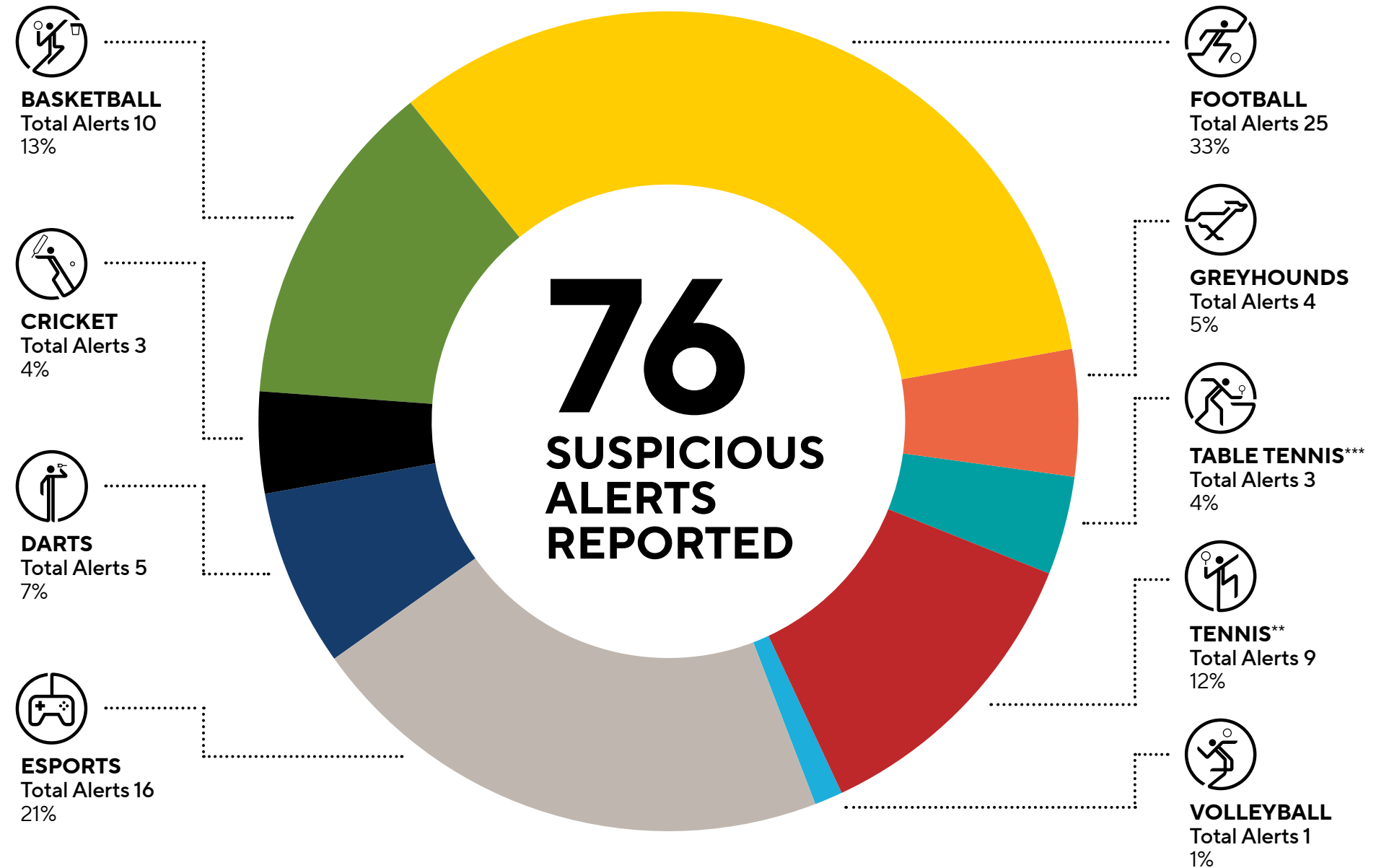
ALERTS

IBIA reported a total of 76 suspicious betting alerts to the relevant authorities concerning 9 sports during Q2 2026*.

* This figure may be revised depending on the outcome of any ongoing investigations.

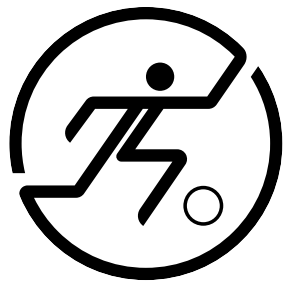
** Of the 9 tennis alerts, 2 were submitted to the International Tennis Integrity Agency (ITIA) as intelligence reports, as they did not relate to events sanctioned by the main tennis tours. However, some players involved may still fall under the ITIA's Tennis Anti-Corruption Program (TACP).

*** All 3 of the table tennis alerts concerned events outside the International Table Tennis Federation (ITTF) competitions.



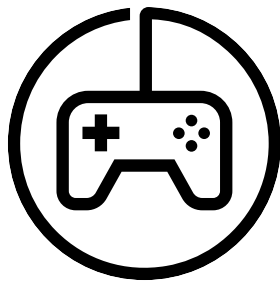

CANADA FOCUS

Competitive regulation moves betting onshore

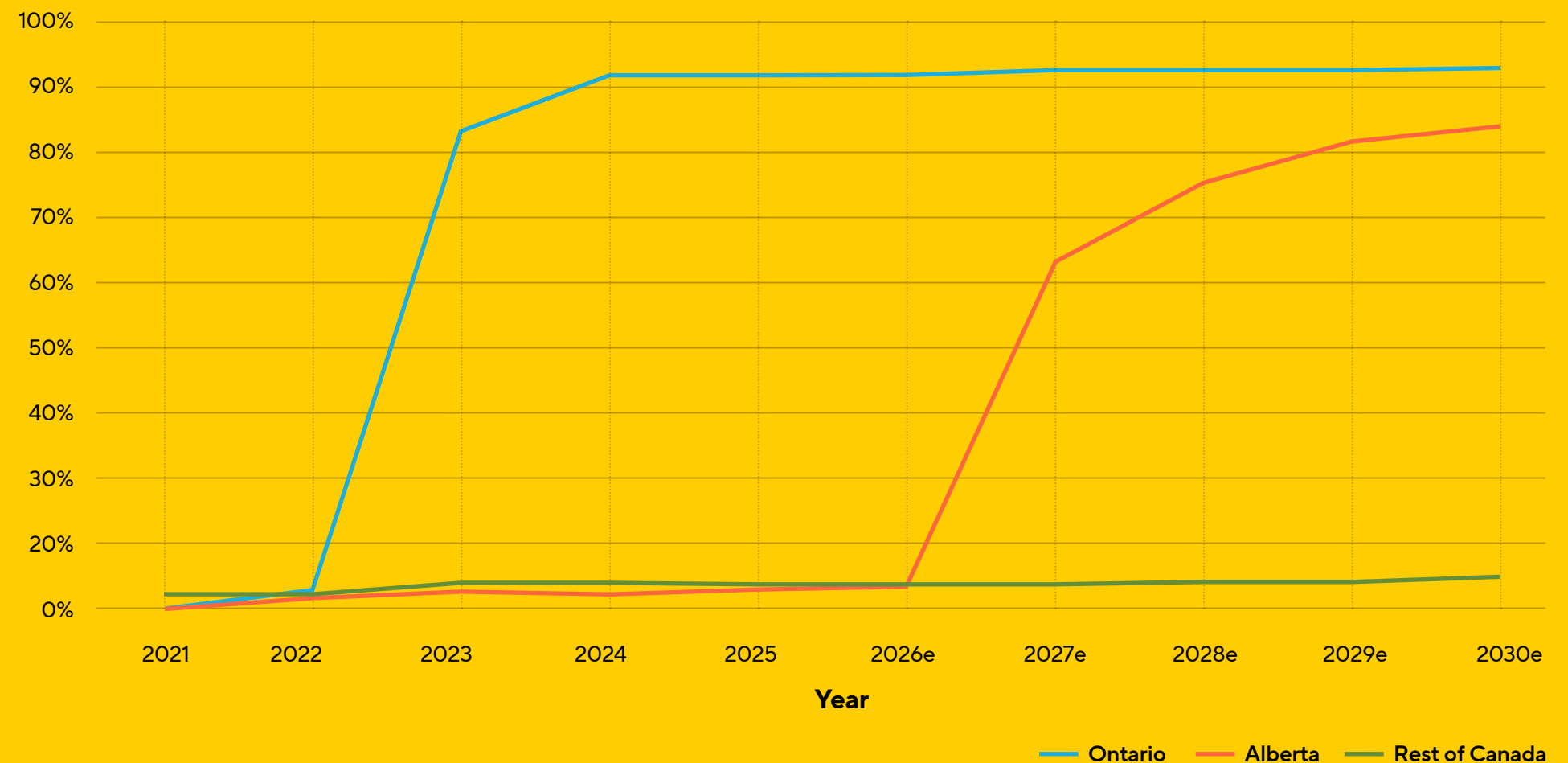
Ontario's online sports betting channelisation rose sharply following the market opening, moving from 5% in gross gambling revenue (GGR) in 2022 to 85% in 2023 and stabilising above 90% thereafter. Alberta is forecast to follow a similar trajectory, while the Rest of Canada remains largely unchanged at low double-digit levels. The contrast highlights the role of competitive regulated markets in moving betting activity onshore and into visible, monitored channels.

CANADA FOCUS

Building a stronger integrity culture through athlete education in Canada

Protecting the integrity of sport starts with empowering athletes. As Canada's regulated sports betting market continues to develop, IBIA has invested in athlete education to help players understand the integrity risks, meet their responsibilities and protect the competitions they represent.

Launched through a CA\$300,000 commitment from IBIA and its members, bet365, Betway and FanDuel, the programme is built around IBIA's 3Rs approach: Rules, Responsibility and Reporting. IBIA Education Ambassador Jean-François Reymond has played a key role in delivering practical in-person sessions, using real-world

examples to engage athletes on betting risks, integrity obligations and how to report concerns.

The programme has already been delivered to nearly 200 Canadian Premier League (CPL) players and staff in collaboration with PFA Canada. It was recently extended to all Canadian Football League (CFL) athletes through a dedicated integrity education initiative run in partnership with Genius Sports.

IBIA's work in Canada shows that integrity is built through collaboration. When athletes, leagues, integrity experts and regulated betting operators work together, sport is better equipped to remain fair, transparent and trusted.

IBIA has invested in athlete education to help players understand the integrity risks, meet their responsibilities and protect the competitions they represent.
